Union County West End Fair Princess

Each contestant must:

1. Be a female resident of Union County, Pennsylvania.
2. Be at least 12 years of age and not over 15 years of age by June 1 of the year entering the pageant.
3. Fill out and submit application.
4. Have written consent from parents or guardians.
5. Dress in Sunday Best or Flower Girl dress.
6. Attend rehearsal and the pageant.
7. Must not participate or hold title in any other pageant during her reign.

Contestants will compete in:

1. Submit a 75-150 word typewritten essay on "What My Fair Means to My Community."
2. Interview with the Pageant Judges.
3. Poise and presentation (appearance and neatness) during the contestant introductions on stage.
4. Ability to communicate (speaking ability) during the question-and-answer segment on stage.

Responsibilities of the Princess:

1. Help during fair week if available (help pass out ribbons at livestock shows, Kids Day, etc.) at the Queen and Fair Queen Committee's discretion.
2. Attend Christkindl Market and help pass out candy canes with next year's fair dates on.
3. Participate in local parades.
4. Attend the following years West End Fair Pageant.
5. Attend other events as requested by the Fair Queen.

The Princess will receive a crown and sash. Once the Princess has completed her year of reign and met all her responsibilities, she will receive her cash award of \$50.00 at the next years Pageant.

Photo Specifications:

- 1. Wallet Size (3 ." high by 2 ." wide)
- 2. Portrait Orientation
- 3. High Resolution on photo paper (no copy paper prints)
- 4. Include a Photographer’s release if the photos you submit were professionally taken and copyrighted on the back.

Each contestant must submit a typed essay on “What My Fair Means to My Community.”

Essay Specifications:

- 1. The essay must be typed or word processed on a separate piece of paper.
- 2. Double-space.
- 3. Include your name on the top right-hand corner of all pages of the essay.
- 4. Include total word count on the bottom right-hand corner of the page. The body of the essay must be 75-150 words. This does not include the title.
- 5. Topic: “What My Fair Means to My Community.”

Judging: Content, Grammar, Spelling and Word Count (body of essay must be 75-150 words)
